Valid Registration for Recycler/Re-Processors of E-waste with Central Pollution Control Board / State Pollution Control Board in terms of Ministry of forest notification number S.O 1035(E) Dated 12th May 2011. A copy the certificate (An Authorized letter issued by concerned State Pollution Control Board for Recycler / Re-processor of E- waste) is must to submit with bid assupportive document.

General Terms & Condition

1. The bidder shall abide by the rules to be declared at the time of Auction.
2. The bidder may inspect the items on a pre-determined date and satisfy themselves about the items they are bidding for.
3. The successful bidder of auctioned items will have to deposit full amount in the Vidyalaya on the same day and vacate the premises immediately by taking out the auctioned articles with them.
4. The items shall be sold to the highest bidder: Tax will be extra, as applicable.
